


THE ACCOUNTS AND AUDIT PROCESS

Section 12 of the Public Audit (Wales) Act 2004 requires community and town councils (and their joint committees) in Wales to make up their accounts each year to 31 March and to have those accounts audited by the Auditor General for Wales. Regulation 14 of the Accounts and Audit (Wales) Regulations 2014 states that smaller local government foodies i.e. those with annual income and expenditure below £2.5 million must prepare their accounts in accordance with proper practices.

For community and town councils and their joint committees, proper practices are set out in the One Voice Wales/Society of Local Council Clerks publication Governance and accountability for local councils in Wales – A Practitioners' Guide (the Practitioners' Guide). The Practitioners' Guide requires that they prepare their accounts in the form of an Annual Return. This Annual Return meets the requirements of the Practitioners' Guide.

The accounts and audit arrangements follow the process as set out below.



Please read the guidance on completing this Annual Return and complete all sections highlighted in red including BOTH sections of the Annual Governance Statement.

APPROVING THE ANNUAL RETURN

There are two boxes for certification and approval by the body. The second box is only required if the Annual Return has to be amended as a result of the audit. You should only complete the top box before sending the form to the auditor.

The council must approve the Annual Return BEFORE the accounts and supporting documents are made available for public inspection under section 30 of the Public Audit (Wales) Act 2004,

The Auditor General for Wales' Audit Certificate and report is to be completed by the auditor acting on behalf of the Auditor General. It MUST NOT be completed by the Clerk/RFO, the Chair or the internal auditor.

Audited and certified returns are sent back to the body for publication and display of the accounting statements, Annual Governance Statement and the Auditor General for Wales' certificate and report.

I have conducted my audit on behalf of, and in accordance with, guidance issued by the Auditor General for Wales.

On the basis of my review of the Annual Return and supporting information, I report whether any matters that come to my attention give cause for concern that relevant legislation and regulatory requirements have not been met.

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2019 of:

External auditor's report

Audit opinion

I am required by law to satisfy myself that:

- the council's accounts are prepared in accordance with the Accounts and Audit (Wales) Regulations 2014 (the Regulations);
- the accounts comply with all other statutory provisions applicable to the accounts;
- proper practices have been observed in compiling the accounts; and
- that the council has made proper arrangements for securing economy efficiency and effectiveness in its use of resources.

On the basis of my review, in my opinion, the accounting statements have not been prepared in accordance with the Regulations or proper practice:

- The accounts have not been prepared on the correct accounting (receipts and payments) basis.
- The closing balance for the year to 31 March 2018 (line 7 and 11) and the opening balance for the year ended 31 March 2019 (line 1) should read £9,497. Total other payments (line 6) reported for the year ended 31 March 2019 is overstated and should read £37,815.
- Line 8 Debtors and line 10 Creditors should be recorded as £0.
- The closing balance for the year ended 31 March 2019 (line 11) should read £46,813.

In my opinion, the following assertions in the Council's Annual Governance Statement do not accurately reflect the Council's governance arrangements:

Assertion 1: The Council states it has put in place arrangements for the preparation and approval of accounts.

The Regulations (regulation 15) require the Council to approve the accounts by 30 June 2019. The Council did not in fact approve the accounts until 29 September 2019.
